# Minutes of the Community Council Meeting (AGM) held on 08.05.19 - 7.00pm at "Y Ganolfan"

1. <u>Chairperson's Welcome</u>: A warm welcome was extended to all to the meeting, when new roles for 2019-20

were discussed.

- 2. Apologies Received: Malcolm Hills, Geraint Micah, Louise Hughes (County Councillor).
- 3. <u>Approval of previous minutes (13.03.19)</u>: Previous meeting's minutes were agreed a true account and approved. Proposed – Keith Carroll Second – Ian Williams Signed – Huw Davies.
- 4. Matters arising from the previous meeting (13.03.19 and 18.04.19):
  - a) A site visit was held at NWR's boundary wall near Friog, with NWR officials and Community Council members to discuss the repair work that needs to be done on the boundary wall and crash barriers.
    Network Rail officers confirmed that they hope to carry out the repairs to the boundary wall in this financial year, and are aiming to start the work on site during the winter of 2019/20.
  - b) Quotes for grass cutting Perthi and Quaker Footpaths = May, July and September War Memorial = May, July, September and November Quaker Burial Ground = May, July and September.

Only two quotes received – Gwynedd Council's = £773.70 + VAT and Geraint Micah's = £480.00 + VAT.

- d) Review Donations Policy → no change = Y Ganolfan £1,000.00, Air Ambulance £250.00, Llangelynnin Churchyards = £500.00 to be given at February's meeting. Other donations = £250.00
- e) Clerk's wages and expenses reviewed:
  - Geraint Edwards voiced a personal interest and completed the "Notification of Personal Interest" form, he did not take part in the discussion nor the resolution of this review.

Members discussed and all agreed to an increase of 2.5% on the clerk's current wages:

Resolution → Wages = £1,140.00 // Expenses = £200.00 // Increase of 2.5% = £28.50 = £1,368.50. Clerk's wages and expenses to be paid biannually - May and November 2019, and to be reviewed annually.

- c) Retaining Wall (near Golwg y Mor, Llwyngwril), has come down and needs building up
  Resolution → inform Highways Department, Gwynedd Council.
- **d) Sunbeach, Llwyngwril** it was noted that a lot of concrete slabs have been built for extra caravans on the site, and on the public "highway" leading to the beach......
