## Minutes of the Community Council Meeting held on 13.02.19 – 7.00pm at “Y Ganolfan”

1. **Apologies Received:** David Griffiths, Malcolm Hills, Huw Davies.
2. **Chairperson’s Welcome:** A warm welcome was extended to all to the meeting.
3. **Approval of previous minutes (09.01.19):** Previous meeting’s minutes were agreed a true account and approved.

4. **Matters arising from the previous meeting (09.01.19):**

a) **Ben Davies and Sam Hadley - Network Rail**

**Re: maintenance work to be carried out on boundary wall/crash barriers between Llwyngwriil and Friog**

Message received on the 12.02.19 from Claire Hickman, Network Rail’s Customer Support Manager for Wales, stating that Ben Davies and Sam Haley would not be able to attend the meeting on the 13.02.19, as arranged, to discuss the above problem.

Council members disappointed that nobody from NWR could attend, and that NWR were still unable to confirm when the work on the boundary wall and crash barriers on this road would be done, though the Community Council raised the problem with Gwynedd Council and NWR over four years ago, emphasising the importance of the crash barriers here for the safety of everyone who uses this road.

**Decision** → contact Network Rail’s Chief Executive for the Cambrian Coast Line for their response.

Contact Liz Saville Roberts and Dafydd Elis Thomas, to ask if they could contact Network Rail to try and expedite the urgently needed maintenance work.

b) **Problem parking** → complaint has been referred to the Safer Neighbourhood Team.

c) **New Perspex for Noticeboard** → Middleton Glass confirmed they do not stock and supply Perspex.

**Gwynedd Council – Community Matters**

- a) It was noted that the large general waste bin/skip near St George's, Llwyngwrl seems to be overflowing with household rubbish before every due collection day. This green bin serves six properties, none of which have proper re-cycling facilities.  
**Decision** → contact Gwynedd Council to ask if it's possible to have a recycling unit/rack placed here, like the one in Rhoslefain and near Nant Farm in Llwyngwrl.
- b) Blocked gulleys on Gwastadcoed Hill → inform Gwynedd Council.
- c) Gwynedd Council's Temporary Road Signs – left on the roadside long after work's been done → inform GC.
