## Minutes of the Community Council Meeting held on 09.10.19 – 7.00pm at “Y Ganolfan”

1. **Chairperson’s Welcome:** A warm welcome was extended to all to the meeting.
2. **Apologies Received:** Dylan Thomas, John Griffiths, David Griffiths, Louise Hughes (County Councillor).
3. **Approval of previous minutes (11.09.19):** Previous meeting’s minutes were agreed a true account and approved.

4. **Matters arising from the previous meeting (11.09.19):**

- b) **Salt Bins to be re-filled:** Prysgau Isaf Road ? – Kevin offered to check if needs re-filling.
- c) **Play Park, Llwyngwriil:** black rubber tiles getting more slippery and dangerous  
→ need to contact G L Jones again regarding pressure washing the tiles and asking them to assess and advice.
- d) **Play Park, Llwyngwriil:** it was noted that the small garden near the play park gates was looking untidy and needed clearing → Huw Davies offered to cut and clear the garden.
- e) **Xmas Trees:** ask John Griffiths to contact Gwanas to order a tree for Rhoslefain.  
Contact Emlyn Roberts to order a tree for Llwyngwriil.
- f) **Historic Mile Posts:** it was noted that these signs are looking a bit "worse for wear" and need painting!  
**Decision** → inform Gwynedd Council.
- g) **Crash barriers - Llwyngwriil to Friog:** still awaiting further information from Network Rail  
**Decision** → contact Network Rail for an update on the proposed work to be done.
